Biographical/Historical note

The Committee on Financial Services oversees the entire financial services industry, including the securities, insurance, banking, and housing industries. The Committee also oversees the work of the Federal Reserve, the U.S. Department of the Treasury, the U.S. Securities and Exchange Commission, and other financial services regulators. Its predecessors include the Committees on Banking and Currency; Banking, Finance, and Urban Affairs; and Banking and Financial Services. The committee was known as the Committee on Banking, Finance, and Urban Affairs from 1975 to 1995.

Committee on Banking, Finance, and Urban Affairs, 96th Congress

Files contain bill files, subject files, committee prints, and official communications. Records contain the all of the files of the Subcommittee on the City, which existed from the 95th and 96th Congresses, including hearing files, chronological files, press releases, and clippings. Subjects of interest include coinage, the Electronic Fund Transfer Act, and the Truth in Lending Act.

The records are arranged into bill files, legislative files, committee prints, official communications and the records of the Subcommittees on the City and on Consumer Affairs.

Rule VII

The records are governed by Rule VII(3)b of the House Rules: (b) (1) A record shall immediately be made available if it was previously made available for public use by the House or a committee or a subcommittee. (2) An investigative record that contains personal data relating to a specific living person (the disclosure of which would be an unwarranted invasion of personal privacy), an administrative record relating to personnel, or a record relating to a hearing that was closed under clause 2(g)(2) of rule XI shall be made available if it has been in existence for 50 years. (3) A record for which a time, schedule, or condition for availability is specified by order of the House shall be made available in accordance with that order. Except as otherwise provided by order of the House, a record of a committee for which a time, schedule, or condition for availability is specified by order of the committee (entered during the Congress in which the record is made or acquired by the committee) shall be made available in accordance with the order of the committee. (4) A record (other than a record referred to in subparagraph (1), (2), or (3)) shall be made available if it has been in existence for 30 years.

Records are all of the files of the Subcommittee on the City, a non-legislative oversight and investigations subcommittee established at the beginning of the 95th Congress and abolished at the end of the 96th Congress. Files are staff memos, press releases, clippings, correspondence related to the hearings, reports, and investigations of the subcommittee.
