Biographical/Historical note

The first Committee of jurisdiction, the Committee on Education and Labor, was established on March 21, 1867, in the aftermath of the Civil War and the growth of American industry. On December 19, 1883, the Committee on Education and Labor was divided into two standing committees: Committee on Education and Committee on Labor. On January 2, 1947, the Legislative Reorganization Act again combined the Committees, renamed the Committee on Education and Labor. On January 4, 1995, the Committee was renamed the Committee on Economic and Educational Opportunities. On January 7, 1997, the Committee was renamed the Committee on Education and the Workforce; on January 5, 2007, it became the Committee on Education and Labor; most recently, on January 5, 2011, the Committee was given its current name, the Committee on Education and the Workforce.

Files contain executive communications numbers in the range of 68 through 5832, petitions and memorials, miscellaneous files described as "other matters," hearing files organized by full committee and subcommittee, committee prints, bill files, and legislative and correspondence files from the Subcommittee on Employment Opportunities. Rule VII

The records are governed by Rule VII(3)b of the House Rules: (b) (1) A record shall immediately be made available if it was previously made available for public use by the House or a committee or a subcommittee. (2) An investigative record that contains personal data relating to a specific living person (the disclosure of which would be an unwarranted invasion of personal privacy), an administrative record relating to personnel, or a record relating to a hearing that was closed under clause 2(g)(2) of rule XI shall be made available if it has been in existence for 50 years. (3) A record for which a time, schedule, or condition for availability is specified by order of the House shall be made available in accordance with that order. Except as otherwise provided by order of the House, a record of a committee for which a time, schedule, or condition for availability is specified by order of the committee (entered during the Congress in which the record is made or acquired by the committee) shall be made available in accordance with the order of the committee. (4) A record (other than a record referred to in subparagraph (1), (2), or (3)) shall be made available if it has been in existence for 30 years.
